Files must be complete by the application deadline in order to be eligible for review by the Admission Committee. Students may not co-enroll in more than one selective program at any given time. (*Applications may be accepted after deadline, if space permits.)

MINIMUM ACADEMIC REQUIREMENTS

1. Applicants must be a currently certified emergency medical technician or Advanced EMT in good standing with a minimum of one year of experience and/or a minimum of 75 patient contacts as an EMT or AEMT and must meet all requirements and submit all documentation listed on page 1 & 3.
2. Courses in progress at time of application deadline will not be considered as meeting these requirements.
3. Your file will be reviewed and you will be notified by mail of the decision approximately 60 days following the application deadline.
4. Science and math courses older than 10 years are not accepted.

SPECIAL PROGRAM REQUIREMENTS

Please note that the following information must be received before courses begin:

1. Health examination conducted within the past two years by a licensed healthcare provider.
2. Immunization Requirements for Health Science Students: Two (2) doses Varicella (chicken pox) vaccine; two (2) doses MMR (measles, mumps, rubella) vaccine; three (3) doses Hepatitis B vaccine AND Hepatitis B titer showing immunity to the disease; one (1) TDAP (tetanus, diphtheria and pertussis) vaccine within 10 years; one (1) dose Meningococcal vaccine (ages 16-21); annual Influenza vaccine; initial "2 step" PPD or Quantiferon Gold TB blood test and then annual TB testing (negative chest x-ray within 5 years AND annual TB Questionnaire also accepted); a complete physical exam within two years. Contact the Health Services Office at 978-630-9136 for more information.
3. Liability Insurance of \$1,000,000/\$3,000,000 coverage is required. Students will be covered under the college's liability insurance policy, which will be billed through student fees.
4. CPR Certification (at BLS Level from the American Heart Association) is required. A certificate of completion must be presented to the program coordinator prior to entry into the courses.
5. All paramedic technology students must participate in the Massachusetts Community College Health Insurance or provide accurate information regarding comparable coverage.
6. Completion of CORI/SORI form and drug and background screenings. Costs for these reviews are the responsibility of the student.

TECHNICAL STANDARDS

Students entering these programs must be able to demonstrate the ability to:

1. Comprehend textbook material at a college level.
2. Communicate and assimilate information either in spoken, printed, signed, or computer voice format.
3. Gather, analyze, and draw conclusions from data.
4. Stand for a minimum of two hours.
5. Walk for a minimum of six hours, not necessarily consecutively.
6. Stoop, bend, and twist for a minimum of 30 minutes at a time and be able to repeat this activity at frequent intervals.
7. Lift heavy loads (patients or equipment) that may exceed 100 pounds with assistance.
8. Determine by touch: hotness/coldness, wetness/dryness, hardness/softness.
9. Use the small muscle dexterity necessary to do such tasks as gloving, gowning, and operating controls on machinery.
10. Respond to spoken words, monitor signals, call bells, and vital sign assessment equipment.
11. Manipulate gauges and valves associated with, for example, oxygen delivery.
12. Manipulate small devices such as syringes, IVs, resuscitation equipment, etc.
13. Identify behaviors that would endanger a person or animal's life or safety and intervene quickly in a crisis situation with an appropriate solution.
14. Remain calm, rational, decisive, and in control at all times, especially during emergency situations.
15. Exhibit social skills appropriate to professional interactions.
16. Maintain cleanliness and personal grooming consistent with close personal contact.
17. Function without causing harm to self or others if under the influence of prescription or over-the-counter medications.
18. Read measurement units with or without corrective lenses.

Students are expected to meet the technical standards for enrollment in college programs. In some cases, assessment and developmental courses may help students meet these standards. Technical standards must be met with or without accommodations. The college complies with the requirements of Section 504 of the Rehabilitation Act and the Americans with Disabilities Act of 1990. Therefore, the College will make a reasonable accommodation for an applicant with a disability who is otherwise qualified.

STUDENT LEARNING OUTCOMES FOR PARAMEDIC CERTIFICATE

Upon successful completion of the Paramedic Certificate, students will be able to:

- Demonstrate personal behaviors consistent with professional and employer expectations of an entry-level paramedic.
- Demonstrate technical proficiency in all skills necessary to fulfill the role of an entry level paramedic.
- Comprehend, apply and evaluate information relative to the role of an entry level paramedic
- Demonstrate a passing score on the National Registry written and practical exams.

BACKGROUND CHECKS, DRUG TESTING AND LICENSURE REQUIREMENTS

A Criminal Offender Records Information (CORI) review procedure has been implemented for students whose academic programs includes the potential for unsupervised contact with persons from vulnerable populations (i.e., children, the elderly and the disabled).

As part of the coursework in the Paramedic program, students are required to complete practical hours in clinical facilities working with patients under the supervision of licensed providers. Clinical sites may require the student obtain certain background checks (state/federal criminal or sexual offender), finger printing and/or drug testing before participating in the clinical experience. Costs for these reviews will be the responsibility of the student.

Refusing to participate in these background checks or drug testing will result in the inability to progress in the program. A positive background check or drug test may also result in the inability to progress in the program.

The prospective student is encouraged to discuss any concerns with the program director prior to acceptance into the Paramedic program. All screenings and background checks are completed AFTER admission/acceptance into the program.

By signing this application, the prospective student understands his/her responsibility to participate in and pay for these background checks/drug tests, if required by the clinical site. By signing this application, the prospective student also understands the consequences of refusing to test, or refusing to undergo the background checks.

READMISSION OR TRANSFER APPLICANTS:

Readmission to the paramedic program is not guaranteed and is offered on a space available basis. Readmission to the program will require successful completion of a readmission competency examination. A student seeking readmission to the paramedic program must follow the application procedure for new students and meet all requirements of general applicants. Students are limited to two admissions (one initial admission and one readmission) in the paramedic program. Mount Wachusett Community College reserves the right to limit the number of readmissions each academic year. The respective programs reserve the right to refuse readmission based on, but not limited to, unprofessional behavior, unethical conduct, and client safety issues. To be considered for readmission, applicants must submit a letter of intent to the Dean of Admissions and Enrollment Management. Students will then be informed of any other admission requirements that must be met prior to consideration of readmission, including but not limited to a Competency Examination.

ACCREDITATION

The Mount Wachusett Community College Paramedic program has been issued a Letter of Review by the Committee on Accreditation of Educational Programs for the Emergency Medical Services Professions (CoAEMSP Executive Office). This letter is NOT a CAAHEP accreditation status. It is a status signifying that a program seeking initial accreditation has demonstrated sufficient compliance with the accreditation standards through the Letter of Review Self Study Report (LSSR) and other documentation. Letter of Review is recognized by the National Registry of Emergency Medical Technicians (NREMT) for eligibility to take the NREMT's Paramedic credentialing examination(s). However, it is NOT a guarantee of eventual accreditation. QUESTION AND ANSWERS

How do I make an appointment to complete my placement testing?

If you have not yet completed college level English and Math, your next step is to take the placement exam. Students may take the placement exam on any of our 3 campuses and options at each of those campuses vary. For more information, please check mwcc.edu/testing or contact Testing Services at 978-630-9244. If you have completed placement testing in the past three years, these scores can be used if they meet the program requirements. An additional fee of \$10.00 will be charged for those individuals who request to retest.

How do I get started in the Paramedic Certificate program?

Students are encouraged to enter the college as an Interdisciplinary Studies (IDSH) student. With this major, you will be identified as a potential paramedic applicant and will be assigned an advisor that will assist you in establishing an educational plan. As an IDSH student, you may complete any of your non-paramedic courses (i.e., English, mathematics, sciences, etc.) then apply to the program when you have met the requirements for consideration.

Can I speak with an advisor about the Paramedic Certificate Program?

Yes, you may attend an information session and meet with a representative from the program and the Admissions department. Transcript reviews are not conducted at these sessions. To reserve a seat, please visit our website at mwcc.edu/enroll/admissions/info-sessions/

How is my file evaluated?

Our paramedic class is selected from a pool of applicants who have displayed the minimum academic requirements for admission to the program. Space is limited and not all applicants are accepted. Applications will be reviewed and candidates will be notified of the admission decision by mail approximately 60 days after the deadline. The process is competitive and your file will be ranked using the following criteria:

- Current EMT license in good standing and a minimum of one year or more work experience including Supervisor's evaluation and/or 75 patient contacts.
- Courses completed and grades received
- Applicants may have completed Essentials of Anatomy & Physiology (BIO152) minimum of a B- and not older than 10 years, or both Anatomy & Physiology I (BIO199) & Anatomy & Physiology II (BIO204) and not older than 10 years.
- Additional EMS certifications
- Proof of English competency

If I am not accepted this year, will I automatically be accepted next year?

No, you are not guaranteed acceptance. All applicants must reapply.

Where do I attend a clinical setting or placement, and how do I get there?

Students are responsible for their own transportation to clinical sites which include healthcare agencies in Worcester, Leominster, Ayer, Athol and Gardner.

Can I apply for Financial Aid?

Yes. Inquire at the Financial Aid Office, 978-630-9169. We encourage all applicants to apply for Financial Aid, using the Free Application for Federal Student Aid (FAFSA), available at fafsa.gov.

Additionally, what must I know?

- It is up to the applicant to read the Technical Standards. It is the applicants responsibility to discuss any accommodation that he/she may need by contacting the Counselor for Students with Disabilities at 978-630-9330.
- The applicant is responsible for ensuring that the application file is complete and that all items are received by the deadline.
- A CORI positive finding may prevent an applicant from successfully completing the paramedic certificate program and may prohibit them from taking the NREMT for Paramedics.
