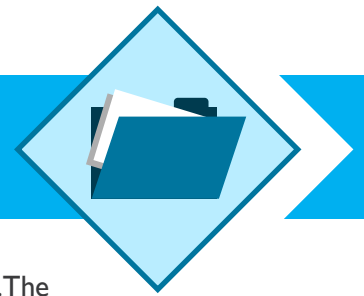


MWCC Officer Training 2021
