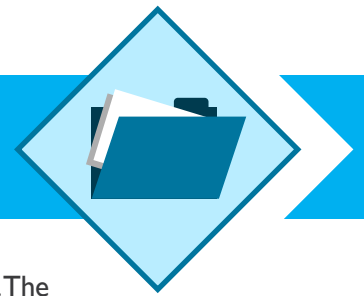


# MWCC Officer Training 2022
