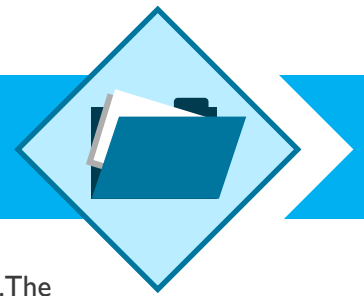


# MWCC Officer Training 2023
